OkPAC

OkPAC (Oklahoma Independent Insurance Agents Political Action Committee) is a non-partisan political action committee established by the IIAO to raise funds for contributions to candidates for elected office in the State. It does not contribute to Federal candidates.

Its primary function is to spur election of candidates to the Oklahoma Legislature who are responsive to the needs of independent agents.

OkPAC can only accept contributions from individuals, partnerships or LLCs.

Federal

InsurPac

InsurPac is the Political Action Committee (PAC) of the Independent Insurance Agents & Brokers of America (IIABA). This non-partisan political action committee raises funds for contributions to candidates for national office on behalf of independent agents. **Contributions support Federal candidates only.**

InsurPAC is a vital part of the IIABA's Government Affairs program – a program that includes professional lobbying, legislative analysis, grassroots contacts, and long-term political relationships. InsurPAC can accept **personal checks only.**

To contribute:

Federal law requires that InsurPAC receive a signed corporate approval form from all corporate agencies before soliciting contributions. Once a form has been signed and filed with the state or national office, contributions from individuals may be solicited and accepted by InsurPAC. Business organization contributions are not permitted. All contributions to InsurPAC must be by personal check.
